1. The posts presented are sanctioned as per the workload calculated taking into account the number of students admitted in the aided faculty or section or subject in operation in the college.
2. It shall be mandatory to enroll in the actual college in the faculty or section or subject mentioned in the proposal submitted by the college for designation and the number of students certified by the university.
3. The workload is calculated taking into account the number of students required for eligibility
4. The batch of number of students prescribed as per government rules will be mandatory for demonstration
5. Hours prescribed for lectures or demonstration or tutorial project work shall be binding as per the norms prescribed by the Govt.
6. As per the prevailing reservation policy of the Government as per the posts sanctioned to the college it is mandatory to certify the reservation point list by the prescribed authority.
7. The sanctioned number of posts shall be reduced in case of reduction in the number of students in subsequent academic years or in case of reduction in the workload of the aided department for any other reason.
8. Regarding the adjustment of additional teachers or non-teaching staff, action should be taken as per the provisions of the prevailing government decision.
9. The posts have been filled based on the grant eligible workload of the college. For recruitment to permissible posts, it is necessary to submit a proposal and obtain a no-objection certificate separately as per the prevailing policy and procedure of the government.
10. Recruitment to sanctioned posts As per the prevailing recruitment policy of the Government, recruitment should not be done without prior permission or no objection certificate. If any appointment is made without following the prescribed procedure without Government permission or if irregularities are found at any level regarding the appointment, the salary of the said post will be disallowed and the entire responsibility of the concerned management and the college will remain.
